



## 2012 LFL Conference Workshops Saturday, August 4, 2012

Workshops A: 1, 4, 5, 6 Workshops B: 2, 3, 4, 5 Workshops C: 1, 2, 3, 6

(1) Dr. David Reardon: Equipping a Post-Abortion Society – This workshop will outline a practical strategy for creating a post-abortion society. This carefully considered approach will create a healing environment for those who have been emotionally wounded by abortion, will draw people together through their common concern for women, and will enforce proper civil liability for abortion related injuries which will bring an end to unwanted and unsafe abortions.



- (2) Jill Stanek: Equipping to Take a Stand This workshop will explore how pro-life activists have and can make significant gains in the battle against the Culture of Death via blogging and social media. The best thing? You don't even have to get out of your bathrobe.
- (3) JT Eschbach: Saving Lives Today: Equip Yourself for Effective Sidewalk Counseling This talk offers practical, effective guidance on sidewalk counseling, including approaches, materials, legal rights, tactics and what to say. It incorporates numerous examples and images gathered from JT's 8 years of experience sidewalk counseling in front of clinics. Those new to sidewalk counseling can learn the basics to effectively assist women; veterans can glean new tips and techniques to enhance their ongoing efforts.
- (4) Carl Schroeder, J.D. & Barb Kinast, R.N.: Equipping for the End of Life Changing medical ethics and societal values have created challenges for Christians in dealing with end of life issues. This presentation will explore these changes, the current state of the law and how Christians can respond in faith and trust.
- **(5) Rev. Doug Merkey: Equipping with Renewal For Life®** Confounded by the complexity of doing ministry in the church? Need refreshment and tools in how to serve people? Come to this workshop and get revived in basic, gospel-driven principles that are essential to robust life ministry in the local church.
- **(6) President's Panel: Equipping the Church** Ideas and resources that individuals and LFL chapters and states can use to promote life issues in congregations, schools, etc.

We seek to make an everlasting difference in the lives of women and their families by bringing them to saving faith.



## **Conference Speakers and Workshop Leaders**



JT Eschbach is a veteran sidewalk counselor, who has assisted couples in front of clinics for over eight years. He regularly hosts workshops and talks on effective counseling techniques, and has traveled across the country to share his insights. JT is

an active volunteer with pro-life organizations, serving as a board member on the Illinois Right to Life Committee, a chairman on Chicago Archdiocese Culture of Life Board, and a SWC trainer with the Pro Life Action League. Outside of pro-life activities, JT has been the Master of Ceremonies for the past two National Catholic Singles Conferences, based in Chicago, Illinois, and Tampa, Florida. He also mentors high school students by teaching catechism classes, giving chastity talks, and leading youth ministry events.



Rev. Dr. Jeff Gibbs is Professor of Exegetical Theology at Concordia Seminary, Saint Louis, Missouri, where he has taught since 1992. His parish ministry experience was at Calvary, St. Helens, Oregon (1979-86) and

Grace, Scappoose, Oregon (1979-89). Jeff is a 1979 M. Div. graduate of Concordia Theological Seminary, Fort Wayne, Indiana, where he also earned the S.T.M. in 1988. His Ph.D. in Biblical Studies is from Union Theological Seminary in Virginia, Richmond, Virginia (1995). Jeff has published articles in the journals of both LCMS seminaries, in Catholic Biblical Quarterly and in The Lutheran Witness. He is the author of Jerusalem and Parousia: Jesus' Eschatological Discourse in Matthew's Gospel and Matthew 1:1–11:1. He is also the New Testament editor for The Concordia Commentary: A Theological Exposition of Sacred Scriptures.



Marlene Eidsmoe, the daughter of Dutch immigrant parents, grew up on a North Dakota farm and now lives with her husband John (who serves on the board of directors of Lutherans For Life) in rural Pike Road, Alabama. She home-schooled their three children for twenty-two years and now teaches Bible and Art at Montgomery Christian School, an

academy for underprivileged children. She has long been inspired by the heroism of Corrie ten Boom in the Netherlands during World War II and will present Corrie's testimony and its meaning for us in full traditional Dutch apparel.

Renee Gibbs is, first and foremost, a daughter of the King! She is the wife of Dr. Jeff Gibbs who teaches at Concordia Seminary, St. Louis, where they have lived since 1992. Renee has earned advance degrees both in Special Education (Webster University) and in Theology (Concordia Seminary). A leading pro-life advocate, Renee




speaks out on behalf of the unborn and in love for those women who have been wounded by abortion. She frequently speaks on life issues to groups and seminary classes, encouraging students in their future roles as pastors and leaders. Renee participates in regular prayer vigils at Planned Parenthood. She and Jeff serve as advisors for the Concordia Seminary Life Team. She advised the Teens for Life group at Lutheran High, St. Charles County, Missouri, taking teens to Washington, DC, for the March for Life every year since 1997. Renee leads numerous Bible studies and mentoring groups for seminary wives. She also speaks at retreats and other functions for Christian women. She has led many seminary mission trips to Guatemala. Renee taught and consulted in Special Education for 18 years. The Gibbses have four grown children and ten grandchildren.



Barb Kinast, R.N. is a Clinical Coordinator at West Suburban Center for Cancer Care in River Forest, Illinois. She graduated from the University of Illinois in 1978 with a Bachelor of Science in Nursing. Her 34-year nursing career has included both patient care and management. For the

last 23 years, her specialty has been caring for patients with cancer and blood disorders. Palliative care and ethics are two of her many areas of interest. She has been active in educating nursing staff and in the local chapter of the Oncology Nursing Society. Barbara is certified in Oncology Nursing. She was selected as the 1999 Leukemia Research Foundation Hematology-Oncology Nurse of the Year, and received the 2004 ONS Pearl Moore Career Development Award. Barbara is a member of Messiah Lutheran Church in Chicago and serves on the Board of Christian Education and as a Bible study leader. (She is famous for her footprint cookies!) Barb and her husband, John, have been married for 32 years, living on the northwest side of Chicago.



The Rev. Dr. Kenneth R. Klaus is Speaker Emeritus of *The Lutheran Hour*® radio program. As Speaker Emeritus, he writes and records a sermon a month for *The Lutheran Hour*, writes and edits Lutheran Hour Ministries' daily devotions, records Bible studies and other video

clips for the LHM Men's NetWork (an online men's ministry resource), and represents Lutheran Hour Ministries at speaking engagements across the country. Klaus previously served as Speaker of The Lutheran Hour from 2002 until his retirement from the position at the end of 2010. Pastor Klaus has 28 years experience as a parish pastor. Before taking the Speaker's microphone, he was administrative pastor of Our Redeemer Lutheran Church in Dallas, Texas. He served the International Lutheran Laymen's League (the same organization as Lutheran Hour Ministries) as its pastoral advisor from 1996 to 2000. He

also held pastoral positions in Minnesota, central Illinois, and South Dakota Lutheran parishes. Pastor Klaus speaks throughout the United States and Canada. A prolific writer, Pastor Klaus has published many works, including volumes one and two of Stories from The Lutheran Hour - A Changeless Christ in a Changing World and two prayer books (one for use by people in the military and a companion book to be used by loved ones at home). Currently he is writing daily devotions available via e-mail from Lutheran Hour Ministries that speak to readers with the holiness of God in the here and now. Pastor Klaus holds a Master of Theology degree from Concordia Seminary in Springfield, Illinois, and a Bachelor of Arts degree in pre-seminary studies from Concordia College in Fort Wayne, Indiana. He also was awarded an honorary title, Doctor of Divinity, by Concordia University Wisconsin in December 2005.



Pastor Doug Merkey graduated with a degree in Marketing from Penn State University in 1989. After several years in the corporate world, he obtained his Master of Divinity from Covenant Theological Seminary in St. Louis in 1999. His awareness of God's love for all human life—born and unborn—came while in seminary. Since then,

Doug has worked as the college and career pastor and pastor of the Life Team at Twin Oaks Presbyterian Church. He has served on the board of Thrive, St. Louis, a local organization that helps men and women in crisis pregnancies or who are struggling with having chosen abortion. In January, 2008, Doug was called by Twin Oaks to launch Churches for Life (www.getintolife.org), and organization that exists to nourish churches as gospel-driven champions of life. Doug counts it his special joy to help Christians see themselves as those who have been rescued by God's amazing love in Christ, and who respond to that love by living humble, joyful people who likewise look to rescue others.



Dr. David C. Reardon, Ph.D., director of the Elliot Institute, is widely recognized as one of the leading experts on the aftereffects of abortion on women, a field in which he has specialized since 1983. He is the author of numerous books and popular and scholarly articles on this topic. His studies have been published in such

prestigious medical journals as the *British Medical Journal* and the *American Journal of Obstetrics and Gynecology* and have proven that abortion compared to childbirth is associated with higher rates of maternal death, psychiatric hospitalization, subsequent substance abuse, clinical depression, and numerous other complications. He is a frequent guest on Christian radio and Christian television talk shows and has been a key note speaker at many state and national conventions for crisis pregnancy centers and pro-life organizations.



Carl F. Schroeder is a practicing attorney in Wheaton, Illinois, where he specializes in Civil Trials and Appeals. He is a certified as a Civil Trial Advocate by the National Board of Trial Advocacy and has been peer selected to Illinois Law and Leading Attorneys. He received his B.A. from Valparaiso University and his

J.D. from Loyola University of Chicago and has written and taught on a variety of legal subjects. He has defended many prolife activists charged in criminal proceedings for their actions to save lives. He and his wife, Diane, are members of Immanuel Lutheran Church in Elmhurst, Illinois. The Schroeder's have four children aged 22–29.



Jill Stanek was a registered nurse in the Labor & Delivery Department at Christ Hospital in Oak Lawn, Illinois. She discovered not only were abortions being committed there, but babies were being aborted alive to die without medical care. When hospital leaders

said that they would not stop, Jill went public and has become a national figure in the effort to protect both born and pre-born infants. Jill has been quoted in the national media on television, on radio, in print, and by local and national legislators. Jill has testified twice before the Judiciary Constitution Subcommittee of the U.S. House of Representatives and in several state legislatures. Jill's written testimony has been read several times in key U.S. Congressional debates on the Partial Birth Abortion Ban and Born Alive Infants Protection Act. Jill remained at the hospital fighting the fight from the inside, until she was terminated in 2001 for reasons related to her public outspokenness to its abortion practices. In January 2003, World magazine named Jill as one of the 30 most prominent pro-life leaders in the movement over the past 30 years. In January 2009, Jill was recipient of the prestigious Life Prizes Award by the Gerard Foundation. Jill oversees her own blog, jillstanek.com, the top ranking pro-life blog in the U.S. Jill is a member of Parkview Christian Church in Orland Park, Illinois. She is wife to Rich, mother to three children, and grandmother to eight grandsons.



Carol Tobias is the president of the National Right to Life Committee, the nation's oldest and largest pro-life organization. A native of North Dakota, she has served on the National Right to Life board of directors since 1987. From 1983 to 1991, she

was executive director of North Dakota Right to Life and in 1991 was hired as National Right to Life Political Director, a position she held until 2005. During her tenure as political director, pro-life majorities were elected to both the U.S. House of Representatives and U.S. Senate. In both 2000 and 2004, she oversaw the efforts of National Right to Life's political action committee on behalf of George W. Bush. She has appeared on ABC's World News Tonight, NBC's Today Show, CNN, The News Hour on PBS, C-SPAN, and Fox News Channel, as well as numerous television and radio programs throughout the country. She has been quoted in the New York Times, Wall Street Journal, Washington Post, Los Angeles Times, and USA Today.



James P. Schroeder – Christian Estate Planning Counselor – grew up on a farm at Laurel, Nebraska. He is a graduate of Concordia College, Seward, Nebraska, with a Master's Degree from the University of Nebraska-Lincoln. Jim taught in

Lutheran schools and coached for four years. He spent ten years as a district representative and general agent for Aid Association for Lutherans before called by the LCMS Foundation in 1989. He and his wife, Sue, have four children: Lukas, Timothy, Mindee, and Adam. Jim is giving a portion of his time as a Christian Estate Planning Counselor for the LCMS Foundation to LFL. He is offering his services to help those who have connections to LFL develop their Lifetime Plan for Giving. There is no charge for his services and LFL pays his expenses. Rodney Rathmann – Vice-President – taught and served as administrator of Lutheran schools in Minnesota and Ohio before joining the editorial staff of Concordia Publishing House where he now serves as the senior editor of day and midweek school

materials. Rodney was a member of the LCMS Sanctity of Life Task Force. He currently serves as vice president of the National Lutherans For Life Board of Directors. He and his wife, Dawn, attend Christ Memorial Lutheran Church in suburban St. Louis. They are the parents of two grown sons and three grandchildren.



Rich Greiner – Treasurer – and his wife Laura, of Dansville, Michigan, have nine children. Rich and his wife own and manage a real estate management firm: GFP Management LLC. He serves on many community associations and is actively involved at St. Matthew Lutheran Church.

Rich is a director of a local community bank and MOST Ministries where he serves as treasurer. His business experience dates back to the 1970s and includes construction, investment, real estate, and military service. Rich has extensive international missionary travel experience.



Lynette Auch – State Representative – and her husband, Douglas, are the parents of two grown, homeschooled children, Crystal and Zachary. Crystal and her husband, Marcus Snearley, PO2 US Navy, are the parents to baby Isaac. Lynette has been active in LFL since 1985, helping to form and charter Southeast South Dakota LFL and the

One of her biggest joys in the pro-life movement has been being involved in the ground-work and fund-raising for an ultrasound machine gifted to a local crisis pregnancy center, with on-going fundraising for the continuation of this ultrasound ministry. Formerly they were also active in the local organizations of 4-H and the Yankton Area Ice Association.



John Eidsmoe is a retired Air Force Lt. Colonel and Alabama State Defense Force Colonel, Headquarters Judge Advocate, and Deputy Chaplain. He is a Professor of Law at the Oak Brook College of Law and Government

Policy, and in his various teaching assignments his students have given him the Outstanding Professor Award or Prof of the Year Award five

times. He has served as Senior Staff Attorney at the Alabama Supreme Court and is currently Legal Counsel for the Foundation for Moral Law. He is an ordained pastor with the Association of Free Lutheran Congregations and serves on the Board of Lutherans for Life and on the Board of the Plymouth Rock Foundation, and is a constitutional attorney who has defended home schools, Christian schools, the right of students to study the Bible in public schools, and the right of public officials to display the Ten Commandments. He has authored 14 books and numerous audio and video lecture series. He holds six academic degrees in law, theology and political science, as well as graduating from the Air Command & Staff College and the Air War College. He is Third Degree Black Belt with the American Taekwondo Foundation, a Fifth Degree Black Belt with the Gospel Martial Arts Union, and a Fifth Degree Black Belt with Black Belts of the Faith International. Colonel Eidsmoe is an avid horseman and skier. He and his wife Marlene have been married since 1970, have three children (David, Kirsten, and Justin), and live in rural Pike Road, Alabama.

Rev. Everette E. Greene was born in Baltimore, Maryland, where he grew up. He attended Concordia College, Bronxville, New York, from 1979-1983, where he received a Bachelor of Arts Degree. He went on from there to

attend Concordia Seminary in St. Louis, Missouri, from 1983-1985 at which time he left school to help his then ailing parents. After leaving school he had various jobs, most involving his occupational second love, driving. He drove everything from armored cars to armored tractor-trailers, regular tractor-trailers, and finally motor coaches (charter buses). During this time his mother went on to her eternal rest in 1987. His father has had many strokes but is now doing well. In 1997 he met Rhonda Sherrice Smith and her daughter Paige. He and Rhonda were married on Christmas Eve that same year. In the summer of 2000 he returned to his studies, this time at Concordia Theological Seminary, Fort Wayne, Indiana. If you are a senior friend of Lutherans For Life you may want to consider establishing a gift annuity. This form of giving helps you use your God-given resources to achieve financial security and make a future gift to support the mission of LFL.

Receive regular fixed payments now! You can establish a gift annuity with as little as \$5,000 in cash or securities. Your gift is made along with you

signing a contract that entitles you to a lifetime of regular, fixed payments. If you wish, you may name a second person (usually your spouse) to receive these income payments after your death. At the death of the second income recipient (if one was designated), your gift annuity remaining value goes to LFL.

The amount of your payments is determined when you establish your gift annuity. Your payments are based on the size of your gift, your age, and the age of the person named as the second beneficiary, if you named one.

How a Gift Annuity works for you and Lutherans For Life: Here is an example of how a gift annuity works: John, age 80, and his wife Mary, age 80, decide to establish a Gift Annuity for LFL. They want to receive regular fixed income payments and make a gift to Lutheran For Life to support its mission after they die. They visit with me for assistance in establishing their gift annuity. I help them fill out their application and assist them in making their gift of \$10,000 for their gift annuity. Based on their ages, they will receive a gift annuity rate of 5.7%. That means that they will receive annual annuity payments of \$570 for their lifetimes. Since a portion of the gift annuity is a charitable contribution they will get an income tax deduction for the year they establish their gift annuity.

And, they enjoy even more tax savings! A little more than one half of their annual payment is tax free

After John's death, Mary will continue to receive the regular payments from their gift annuity. After her death, the remaining balance of on their gift annuity will go to Lutherans For Life. Generally this is about one half of their gift amount. If they live longer than their normal life expectancies, Lutherans For Life will receive less than one half of their gift.

Please keep in mind that once you establish your gift annuity, you may not add to or change the agreement. You may however make additional gift annuity agreements.

Remember, your age at the time you establish your gift annuity determines your gift annuity payout rate. The older you are, the higher your rate. There is no cost to establishing your gift annuity.



#### Equipped to be Christian Stewards

God's word says: "Therefore do not be anxious, saying, 'What shall we eat?' or 'What shall we drink?' or 'What shall we wear?' For the Gentiles seek after all these things, and your heavenly Father knows that you need them all. But seek first the kingdom of God and his righteousness, and all these things will be added to you" (Matthew 6:31-33).

Are you worried or anxious about what you will eat or drink? Are you concerned about the type of clothes you wear? Do you trust God to supply all your daily needs? Are you worried about having enough money to pay your bills?



Seeking God's Kingdom involves growing in the knowledge of His Word so we can discern truth from error and loving the Lord with all our heart, soul, and mind. We commit our lives to Christ, attend worship services, take communion, and ask for daily forgiveness from the Lord. Why do we need His forgiveness daily? Although we are Christians, we still sin daily. Thankfully, because of Christ's suffering and death, we have forgiveness and eternal life as a free gift.

Other ways we seek God's Kingdom is by praying for ourselves and others, studying God's Word and reading devotions like *Portals of Prayer*. We talk to our family, friends, and those we meet about Jesus, the author and preserver of our faith. We talk to those we meet about life issues and our faith in Christ as Savior and Lord. As we put Him first we trust in the Lord with all our heart. We believe God's promises. He has promised to take care of us. And He will. Even when difficult times come He walks with us through the trials of life.

Another way we put God's Kingdom first is by remembering the Church and its needs. We donate a portion of our earnings to the Lord's work. 2 Corinthians 9:6-8 says, "The point is this: whoever sows sparingly will also reap sparingly, and whoever sows bountifully will also reap bountifully. Each one must give as he has decided in his heart, not reluctantly or under compulsion, for God loves a cheerful giver. And God is able to make all grace abound to you, so that having all sufficiency in all things at all times, you may abound in every good work."

Besides remembering our congregation, we should also remember ministries we are passionate about—like Lutherans For Life.

God's Word teaches us a lot about being good Christian stewards. We remember that the Lord gave us everything—physical life, family, home, food, faith, and eternal life in heaven. God owns all our possessions. They are His, not ours. As we learn about stewardship through the Bible we become equipped to be Christian stewards. In 1 Corinthians 16:1-2 the Bible says, "Now concerning the collection for the saints: as I directed the churches of Galatia, so you also are to do. On the first day of every week, each of you is to put something aside and store it up, as he may prosper, so that there will be no collecting when I come."

God's word tells us to plan ahead for needs that will arise so we are not caught unaware. We should set aside some of what we earn for needs that will arise. Planning for the needs of the Church is just good stewardship.

Many needs arise in today's world. Sometimes they come from natural disasters like tornadoes or floods. Houses, buildings, and towns are destroyed. Individuals and families are left homeless and alone. Jackie, a 70 year old mother and grandmother, was in the Joplin, Missouri, tornado last year. At the time of the tornado she was in the hospital recuperating from surgery. The hospital was seriously impacted, but God kept her safe. When tragedies like these occur, we pray for the people, volunteer to help, and give a gift of support.

Sometimes financial needs come from bad choices and decisions someone made. It might be someone you don't know at all. Or it might be your daughter or granddaughter who is pregnant and needs help and support. As we seek first His kingdom, we are there for friends and loved ones. We tell others of the

importance of life, of God's forgiveness through Christ, and give of our time, talents, and treasures to help. Do you know there are over one million nonprofit organizations in the United States? Many are Christian organizations that do wonderful mission work and accomplish much for the Lord. Lutherans For Life is one of them. Lutherans For Life has three initiatives that will help reach more people with the good news about life. The following are summaries of these initiatives:

Renewal for Life<sup>®</sup>: This is a major initiative from Lutherans For Life that seeks to equip Lutheran congregations to be Christ-centered, enthusiastic, and ongoing voices for life. RFL is a way to help congregations incorporate life issues into their ongoing ministry. This initiative helps pastors and congregations deal with the life issues more effectively. Through RFL, we provide members with an online library of easy-to use, Word-based For Life resources. RFL also supports and trains Life Advocates who assist the pastor and other leaders in the congregation. These are volunteers from the congregation who are in contact with LFL, receive updates and ideas, research the online library, and organize and coordinate the life ministry of the congregation. Our current strategic plan includes securing needed funds to expand this initiative to include Directors for Renewal For Life in numerous states. In 2011 we hired our first part-time regional Renewal For Life Director of Texas. Jean Amundson, now works with Renewal For Life congregations, their leaders, and RFL volunteers.

**Teaching for Life**<sup>®</sup>: Teaching For Life<sup>®</sup> is a Gospel-centered curriculum developed to help Lutheran school teachers apply God's Word to the life issues. This curriculum teaches nine key pro-life concepts, one for each month of the school year, and provides ideas on how to integrate them into religion, math, social studies, and other subjects. As funds become available we will expand this initiative to include: adult Bible studies, Confirmation bookmarks, Sunday school resources, and a VBS curriculum.

**Generations for Life**: Our newest initiative, Generations for Life, seeks to establish LFL as a leader in providing Gospel-centered, For Life resources and creating opportunities for younger generations of Lutherans to have an influence on their peers in the Church and society. The first phase of this initiative includes establishing and maintaining relationships with leaders on Lutheran campuses of universities and high schools, and developing multi-media resources for the younger generations. We are currently developing an online, interactive training course for youth, young adults, and those who teach them, such as pastors, teachers and youth leaders

#### A Brief History of Lutherans For Life



Lutherans For Life began as a personal dream of Dr. C. Jack Eichhorst. His efforts to make that dream a reality commenced in 1976 when Jean Garton, Robert Jensen, Leigh Jordahl, Sam Nafzger, Richard Neuhaus, and

Michael Rogness agreed to meet with him to "explore common concerns about human life issues with a view to organizing a pan-Lutheran group to deal with them." Seventeen people attended a meeting in St. Louis on May 24, 1977, initiated by Dr. Ralph Bohlmann, Rev. Sam Nafzger, and Dr. J.A.O. Preus. As a result, a committee consisting of Jack Eichhorst, ALC theologian; Jean Garton, LCMS laywoman; Leigh Jordahl, LCA professor; and Eugene Linse, LCMS professor, met at Concordia College, St. Paul, Minnesota, on August 22, 1978, to consider an organizational structure. A name was chosen; a philosophy was adopted; and officers were selected. Garton became President; Eichhorst, Vice President; Jordahl, Secretary; and Linse, Executive Director.

As its first official act, Lutherans For Life sent letters of announcement to the presidents of the American Lutheran Church, the Association of Evangelical Lutheran Churches, the Lutheran Church in America, The Lutheran Church-Missouri Synod, and the Wisconsin Evangelical Lutheran Church. A request was made of the presidents to urge their members to observe October 1, 1978, as Respect Life Sunday and "with prayer and meditation express thanks for their own lives and also sadness for the lives of pre-born children that have been terminated because they were unwanted."

Lutherans For Life (LFL) was officially incorporated on April 17, 1979, with its national office located on the campus of Concordia College, St. Paul, Minnesota. At the time of incorporation, the first board consisted of Dr. George Muedeking and the officers. Soon the board included twelve members; and over the years, numerous Lutheran pastors and laypeople faithfully served on the National Board of Directors.

Rev. Edward Fehskens joined the ministry as Executive Director in August of 1985. In May of 1991, the headquarters of LFL relocated to Benton, Arkansas, southwest of Little Rock. A structure that housed the "Congo Mercantile" for 63 years was

converted into an office as well as living quarters for the director's family.

The philosophy of LFL was revised in 1992. It states:

Lutherans For Life believes that the Church is compelled by God's Word to speak and act on behalf of those who are vulnerable and defenseless. The crisis of our time is the repudiation of biblical truth manifested in the wanton destruction of innocent human life through legalized abortion-on-demand and the growing threat to the lives of others through legalized assisted suicide and euthanasia. Therefore, we will strive together, as Lutherans For Life, to give witness from a biblical perspective to the Church and society on these and related issues such as chastity, post-abortion healing, and family living.

From 1992-1996, LFL produced a national radio program on the *Jubilee* network. *Speaking of Life* featured daily commentaries by Dr. Jean Garton.

In 1995, Rev. Fehskens resigned his position as Executive Director to return to full-time parish ministry. During his ten years of service, he helped build a strong network of chapters and state affiliates. At the 1995 convention, Dr. Jean Garton was honored for 17 years of service. Linda Bartlett was elected President of the board of directors of LFL.

Rev. Dr. James I. Lamb became the new Executive Director in April of 1996. In May of that year, LFL's headquarters relocated to Nevada, Iowa, north of Des Moines.

Lutherans For Life, Inc. has assisted in the development of Lutherans For Life of Australia and Lutherans For Life of Canada in addition to working with interested pro-life Lutherans in other countries. At the request of a member of the USSR Academy of Sciences in Moscow, LFL provided them with resources on abortion, chastity, and post-abortion healing. In 1996, LFL was invited to Romania (at that time the country with the world's highest abortion rate) to assist in the development of Pro-Vita, a Romanian Christian pro-life group. Since that trip, LFL has supported Pro-Vita financially; many brochures have been translated into the Romanian language; and two caring pregnancy centers have been developed. Opportunities exist for continued involvement with Pro-Vita.

The Board of Directors adopted the following Mission Statement in 1997:

The Mission of Lutherans For Life is to witness to the sanctity of human life through education based on the Word of God.

The Campus Life Project, which seeks to encourage students to become advocates for human life, was launched at Concordia University, Mequon, Wisconsin, in September 1997. Other Concordias, as well as secular colleges, have benefited from this project.

National LFL officially went "on-line" in 1997, providing Christian pro-life resources and timely information by way of a web site:

www.lutheransforlife.org

In 1998, Lowell Highby came on staff as the first Director of Media and Development (now Director of Communications). The intent of this position is to enhance and expand the avenues of LFL's outreach and its "For Life" message.

In 2004, Diane Schroeder, who had been Treasurer, was elected President of Lutherans For Life. Diane took over from Linda Bartlett who stepped down after serving as President since 1995.

In early 2009, LFL contracted with Kay L. Meyer, from St. Louis, Missouri, to work part-time as Director of Development.

Also in May of 2010, James P. Schroeder, began serving LFL as a Christian Estate Planning Counselor.

In February of 2012, Dale Olson joined the staff as Director of Operations.

In June of 2012, Laura Davis became the first Director of Generations For Life as well as a Development Counselor.

LFL has developed a wide variety of pro-life and family resources. Videos have included: Bearing Burdens (an honest look at euthanasia), Family Matters (an exclusive interview with Dr. James Dobson), For Life (the mission, ministry, and biblical foundation of LFL), Who Broke the Baby (based on Dr. Garton's book of the same title), and Who Will Speak For Me? (featuring the music of Amy Grant and Don Wharton). LFL of Missouri received a substantial grant to develop Celebrate the Life (now out of print), a sanctity of human life curriculum formerly available through Concordia Publishing House. The educational manual, Living With Dying, provides materials on euthanasia, assisted suicide, "living wills," and other end-of-life issues. The quarterly journal, LifeDate, is mailed to LFL members and

interested persons nationally and internationally. *Directions* is published quarterly for LFL Chapters, State Federations, and Life Ministry Coordinators. Life Sunday resources, including sermons and bulletin inserts, are new each year. LFL's *Life Resource Catalog* offers an assortment of brochures, tracts, Bible studies, curricula, and audiovisuals from the Christian perspective.

Resources for pastors, congregations, and lay people are provided at the national headquarters and in the field through LFL Leadership/Speaker Training Seminars, and other educational events. Word of Hope, LFL's post-abortion ministry, brings hurting women together with Christian caregivers so that hope, healing, and reconciliation with the Lord might be experienced. LFL affiliates have established caring pregnancy centers, post-abortion ministries, and congregational programs that provide supportive services for those confronted with unplanned pregnancies. LFL holds an annual national conference.

LFL co-sponsored two *amicus curia* ("friend-of-the-court") briefs to the U.S. Supreme Court and continues to motivate Lutheran citizens to be "salt and light" in a culture that increasingly embraces death as a solution to human problems. LFL is represented on the National Pro-Life Religious Council.

Numerous LFL state affiliates and local chapters exist to serve both individuals and congregations. Participants in the Life Ministry Coordinator Program work to encourage pastors and congregations. As a grassroots organization which desires to help others live out their faith according to God's will, Lutherans For Life seeks to share Jesus Christ through teaching, caring, and serving.
