A number of Planned Parenthood locations plan to close because of a lack of patients -- not as a result of increased clinic regulations. OREGON: Planned Parenthood says it plans to shutter three clinics in the Portland area: in Clackamas, Gresham, and Clark County. In April, it closed an office in McMinnville. The organization reports a 30 percent drop in patient visits. IOWA: The Planned Parenthood of the Heartland affiliate announced plans to close facilities in Red Oak and Creston, saying the centers each averaged about one patient per month. Freedom-Giving Adoption by James I. Lamb

Ever been enslaved? Paul writes, “**In the same way we also, when we were children, were enslaved to the elementary principles of the world**” (Galatians 4:3). And again in verse 8, “**Formerly, when you did not know God, you were enslaved to those that by nature are not gods.**” Paul wants his readers to know how hopelessly far from God they were so they could understand the incredible grace of God in bringing them from slaves to sons of God through adoption in Christ (Galatians 4:7).

Ever been enslaved? Yes, we have, and if our freedom-giving adoption happened at our baptisms, we still know what that enslavement was like. Our sinful nature constantly seeks to enslave us every day. Those pesky sins keep popping up again and again.

Our dog, Chew-E, when he was a puppy, illustrated this. One of the “elementary principles” that enslaves puppies is biting. We made progress in freeing him from this enslavement with loud “NO’s!” and raps on the nose. Then the grandkids came. Their excitement excited Chew-E and the biting was back with fervor. Our grandchildren bear the marks of this over enthusiastic good puppy gone bad.

Ever been enslaved? Yes, we have, “But ...” Galatians 4:4 begins with this very powerful Gospel word. The chasm between enslavement and sonship is impossible for us to bridge. We don’t even want to try. BUT God did bridge the gap through His adoption process. “**But when the fullness of time had come, God sent forth his Son, born of woman, born under the law, to redeem those who were under the law, so that we might receive adoption as sons.**”

Ever since the fall into sin, God worked through historical events according to His redemptive purpose. When all was ready, He sends His Son, not in some spectacular way, but as a speck conceived in Mary’s womb. He was born true man and true God. Born under the law to keep it in our stead and to bear the weight of our transgressing it and then to pay the price of our redemption with His suffering and death. His resurrection validated it all. Not only are we freed from our enslavement, we are declared holy, sons of God through adoption.

Now a word to you ladies feeling uncomfortable with the use of “sons.” Some translators change this to “children.” That does a great disservice to you. For in Jesus’ day, only sons received the inheritance. But that is not the case when it comes to salvation. We all are sons, heirs of eternal life. And in this life we have a brand-new, intimate relationship with our Father as the Spirit enables us to call Him, “Abba! Father!” (vs. 6) “Abba” being a less formal term of endearment, perhaps akin to our “dad.”

Thanks to you, LFL continues to apply this “slave to sonship” message to the life issues and equips others to do the same. Many are enslaved to the elementary principles of our god-less culture. Others are enslaved to the god of death to rescue them from problems. We all know how easily we fall back into such slavery. But we also all know the message of our adoption into sonship.
