The analysis released by the Guttmacher Institute notes, “This brings the number of restrictions enacted since 2010 to 282.” Although far fewer than the 70 new laws enacted in 2013, the number of pro-life laws in the first half of this year already exceed the number of laws enacted in the previous year, according to the report. Pro-life gains in 2015 state legislatures so far involved a wide range of regulations including waiting periods, limitations on the provision of abortion medication, abortions later in pregnancy, patient safety regulations for abortion providers, and regulations of abortion facilities.
