He was deprived of food and hydration for nine days before his death. He was 42. The case involved what was considered to be a case of euthanasia without explicit consent. The family was involved in years of legal battles over his fate. On June 28, France's highest appeal court ordered that treatment and care, including food and fluid, be withdrawn from Lambert.
